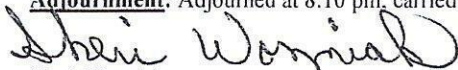
A motion was made by Conover, supported by Wozniak to approve as amended Ord#238 Data Center Moratorium, Kroa voted No, carried.
